Please note that class schedules for each proficiency level may vary from semester to semester.

This is an intensive Korean language program with classes held every weekday, Monday through Friday.

Students should apply only after careful consideration if they are genuinely committed to attending the Korean Language Program. Please note that cancellations and refunds are subject to the Refund Policy Guidelines below.

The tuition fee must be paid in full before classes begin.

As international wire transfers are not accepted, students must visit a bank and make the payment as soon as possible after arriving in Korea.

Refund Policy Guidelines

Article 1 (Refunds)

As a general rule, tuition fees paid by students enrolled in the Korean Language Education Program for Foreigners at the Global Education Center are non-refundable. However, tuition fees may be refunded in the following cases:

<Amended on September 12, 2018 and March 4, 2020>

1. If the applicant's visa application is denied.
2. If a student who has been admitted to the program decides to withdraw after obtaining a visa but before entering Korea.
3. If a student withdraws from the regular program due to returning to their home country, admission to a university, transfer to another university, withdrawal from the program, or other unavoidable circumstances.
4. If the course is cancelled due to an insufficient number of enrolled students.

Article 2 (Refund Amount)

The amount of tuition to be refunded shall be determined according to the following criteria:

<Amended on September 12, 2018 and June 10, 2026>

1. Cases falling under Article 1, Item 1:
100% refund of the tuition fee
2. Cases falling under Article 1, Item 2:
100% refund of the tuition fee
3. Cases falling under Article 1, Item 3:

The following refund criteria shall apply:

a. Before the first day of classes: Full refund

b. Before one-third of the total class hours for the registered semester has elapsed: Refund of two-thirds (2/3) of the tuition fee for the semester

c. Before one-half of the total class hours for the registered semester has elapsed: Refund of one-half (1/2) of the tuition fee for the semester

<Amended on June 10, 2026>

d. After one-half of the total class hours for the registered semester has elapsed: No refund

<Amended on June 10, 2026>

4. Cases falling under Article 1, Item 4:

100% refund of the tuition fee
